RE: The reviving of HR 2749 from 1995 (Bill to investigate fraud or criminal activity of Alfred Kinsey)

Dear Lawmaker,

In light of the U.S. Supreme Court's decision on June 27, 2025 in Case No. 23-1122, *Free Speech Coalition Inc., et al. v. Paxton, Attorney General of Texas*, we, Purple for Parents United, The Matthew XVIII Group and our colleagues from the International Coalition 4 Children, are requesting you to take further action to protect children from obscene and pornographic content. This case does not simply have implications for America's children, but also for vulnerable children across the globe.

The Matthew XVIII Group and the Reisman Institute submitted to the Supreme Court a significant amicus brief in the *Paxton* case. The brief outlined in detail the child sex crimes and fraudulent data of Alfred Kinsey and the Kinsey Institute. Written by the founder of The Matthew XVIII Group, Audrey Werner, the brief graphically described not only the immoral origins of this "scientific" data, which has been used to promote sexual promiscuity among our nation's young people, but the actions Audrey was instructed to take as a sex educator and health nurse based on these standards, ones that have unfortunately wormed their way into our education system.

In this brief, Audrey acknowledged that "Children represent the future of society. They are also our most vulnerable citizens still in the process of formation..." We are grateful to the Supreme Court for its support of the state of Texas by upholding the law at issue. Its seminal ruling in the *Paxton* case supports the legislative action taken by Texas to protect those so important to all of us, our children.

It's important to highlight that this Supreme Court case came on the heels of a historic victory in Indiana. In 2023, Purple for Parents United, along with a freshman Indiana legislator, led the way in defunding the Kinsey Institute of taxpayer dollars. During the 2023 bi-annual budget, an amendment was passed which removed Indiana tax dollars from funding the Kinsey Institute for the first time in history.

Additionally, Purple for Parents United brought the global Kinsey Report App to the attention of Indiana's former Attorney General. This global app permitted any child molester, through the

app's survey, to report their "data" back to the Kinsey Institute. Thankfully, due to the efforts of Purple for Parents United, this app is no longer functioning; however, the question remains, "where is the data and what did it contain?"

We believe, however, that more needs to be done to reclaim the innocence of children in our societies both at the national and international levels. We are calling on you to revive a bill from 1995 which would have investigated the origins of such horrendous abuse of innocent children - HR 2749. This bill was sponsored by Texas Rep. Steve Stockman (9th Congressional District) and it sought to determine if the content of Alfred Kinsey's books, *Sexual Behavior in the Human Male* and/or *Sexual Behavior in the Human Female*, were the result of any fraud or criminal wrongdoing. The bill garnered many supporters from Congress who sought to take such action; however, they were met with opposition, and the bill failed to pass.

The result of Kinsey's phony data and "science" has had many detrimental consequences on our society via single motherhood, the spread and treatment of venereal diseases, WIC, TANF, taxpayer funded childcare, drug abuse and more. States and governments across the nations have had to deal with the horrific fallout of the sexual revolution and the perversion unleashed on our children.

In addition, we find it necessary to call into question the use of printed propaganda that has permeated our culture based on Kinsey's "science" in order sexually to pervert children. In 2023, the Purple for Parents United team took a look at the publishing companies which are distributing this material to schools and libraries across the world and found that many of them are tied to the World Economic Forum, the United Nations and the Council on Foreign Relations.

These publishing companies are publishing, selling and distributing (included expanded distribution) books against their own publishing guidelines. Below are two examples: KDP and Penguin Random House.

KDP Guidelines: "Offensive content: We don't sell certain content including content that we determine is hate speech, promotes the abuse or sexual exploitation of children, contains pornography, glorifies rape or pedophilia, advocates terrorism, or other material we deem inappropriate or offensive."

Penguin Random House Guidelines: "User Submissions must be respectful of others. Epithets or other language or material intended to intimidate or to incite violence are strictly prohibited. Your User Submission may not include any negative comments that are connected to race, national origin, gender, sexual orientation or physical handicap or that are defamatory, slanderous, indecent, obscene, pornographic or sexually explicit."

Therefore, we are additionally requesting an investigation into the publishing and distribution of sexually obscene content that has resulted from the debased Kinsey "science". It is clear that through Kinsey's deceitful data and "science", our society has been socially re-engineered to accept sexual promiscuity. This acceptance has resulted in devastating consequences to

families and children, as well as to the moral fiber of the world population. It is for the purpose of restoring that which was stolen from us, social virtue and purity, that we respectfully request that you seek to pass an updated HR 2749 and finally investigate the fallout of the sex crimes of Alfred Kinsey.

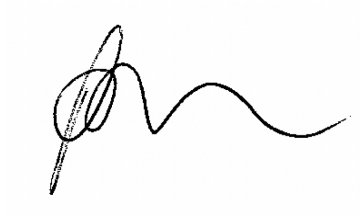
